The following is a summary of the interactions, comments and items discussed. While this summary is not intended to represent a complete or comprehensive account of the meeting, it is intended to reflect the salient points raised and issues for further consideration. 1. Secretary Report - David Krickbaum

The minutes from the May 12, 2006 meeting were distributed. The minutes were approved, by a motion and a vote.

2. Treasurer Report – David Mallory

David gave an update regarding the unresolved IRS penalty. He reported that 3 abatement requests had been sent, but only the last one sent via registered mail was recognized. A check for the penalties has been sent to the IRS, but it is expected that that the penalties will be refunded.

The Treasurer's Report was distributed. It was noted that there was approximately \$1800 remaining in the disaster relief budget. After discussion it was decided to make a \$1000 donation related to the floods in Douglas County that occurred the previous weekend and to make a \$1000 donation to the ASFPM Foundation. The line item will be re-budgeted to use funds from the workshop budget that will probably not be used. The report was approved by a motion and a vote.

3. Regional Representatives' Reports

No regional representatives were present.

4. Committee Reports

- a) Floodplain Kallie Bauer reported that the CFM review course and exam will be offered at the conference. CEC will be available for conference attendance.
- b) Stormwater Quality No report was made.
- c) Scholarship Jeremy Franz reported that the UWRI scholarship recipient has been selected, but not notified yet. The CASFM scholarship will be advertised at the beginning of the fall semester. Two previous recipients will present papers at the conference.
- d) Outreach Chuck Childs distributed an email regarding CASFM participation in a panel discussion at the American Council of Engineering Companies' Environment and Energy Committee meeting. Tom Browning and Kevin McBride may be able to attend the meeting.
 - CASFM's possible involvement in legislative issues was discussed. Chuck will conduct some fact finding and will present his findings at the next meeting.
- e) Membership No report was made. It was noted that membership is approaching 600.
- f) Training Slow progress is being made to develop the training program.
 - Kevin Houck reported that he will be conducting a CLOMR workshop and one other workshop. In 2007 CAFSM and CWCB will be conducting a joint workshop regarding the state criteria manual.
- g) Website No report was made.

5. 2006 Annual Conference – Robert Krehbiel

The conference program was reviewed and moderators were selected.

6. 2007 Joint Arid Regions/CASFM Conference

The contract has been signed and the deposit will be set. Approximately 350 attendees are anticipated.

7. CASFM Magazine

The magazine is in print. 2000-3000 copies will be distributed to members and local agencies.

8. Other Business

Tom Browning noted that Brad Anderson was elected to the ASFPM Board of Directors.
