
Thanks to a fantastic key note address by Ed Thomas of Michael Baker, many enlightening technical presentations and a great venue during the peak color week of the year, the 21st annual CASFM conference was a success! Turnout was higher than expected, with a total of 279 attendees who made the trek to beautiful Snowmass Village.

We tried to vary a few things with the program this year and while some more tweaking will likely occur next year, there was positive feedback about the changes made. Modifications included two workshops offered on Tuesday afternoon, replacing the plenary session with additional technical presentations and offering two workshops on Friday morning.

Three field trips were offered: a horseback riding excursion, a mountain biking adventure and a tour of the trans-basin diversion facilities on Independence Pass. While all three received high marks from the evaluation survey, they were not well attended. THANK YOU ONE AND ALL!

This past year was an important one for Colorado Flood Risk Management. Through the leadership and tireless efforts of staff at the Colorado Water Conservation Board (CWCB), new enhanced floodplain management standards went into effect on January 14th. As many of you know, the new rules provide for freeboard, more restrictive floodway delineation and new requirements for critical facilities located in the special flood hazard area. CASFM made important contributions through participation in the advisory committee and presentations before the CWCB Board. Several CASFM members gave testimony on behalf of their respective communities as well. CWCB staff asked Ed Thomas to speak at the final hearing. His presentation closely followed the key note address delivered at our 2010 Annual Conference, FEMA Region VIII was instrumental in funding this effort and in extending his stay to provide assistance to the Cities of Fort Collins and Colorado Springs. Basil Hamdan worked in a four-hour workshop and Northeast Region Social as well.

The year ahead will be busy and productive. Robert Krehbiel is again the Metro Region Representative and has already organized several successful social events. He and Shea Thomas will lead the efforts on Annual Conference planning.

CASFM continues to enjoy outstanding conferences year after year. Marsha Hilmes-Robinson is working with FEMA Region VIII to bring the fielddeployed version of the four-day CRS Workshop to Colorado in late March. And, I'm sure everyone is aware that CASFM, together with the Natural Hazards Center and the ASFPM Foundation will host the Colorado Flood Risk Symposium. CAS-FM was selected by the Foundation in completion with several other state chapters. The symposium will be a one-day event by invitation in April. 2011 ASFPM National Conference

ASFPM's annual conference this year is the week of May 15-20, 2011 in Louisville, Kentucky. Throughout the week, 200 of the industry's experts will conduct plenary and concurrent sessions and share the state-of-the-art in techniques, programs, and resources to accomplish flood mitigation, watershed management, and other community goals. A three-day comprehensive exposition features the materials, equipment, accessories, and services vital to get the job done. Supplementary technical field tours and training workshops provide in-depth training. Numerous networking activities offer additional opportunities to learn from each other.



Training Committee

The CASFM Training Committee is proposing 4-5 Bar Stool Series training events for 2011. These short training workshops are typically 1-2 hours in length held at the end of the day, often qualify for CFM credit, are provided at minimal cost, and are followed by a social time, thus the name "Bar Stool Series". Actual dates and times have yet to be determined but will be announced through email and the CASFM website. We are currently investigating the following topics for the Bar Stool Series:

- Culvert rehabilitation and restoration
- Partially grouted riprap design and construction
- Levee overtopping physical modeling results (from the CSU Engineering Research Center's hydraulics laboratory)
- LID design examples
- Ecological stream restoration
- 404 permitting

In addition to these topics, opportunities routinely arise for other training opportunities. We'll pursue and help promote those as they come up. One such opportunity for 2011 is a FREE 2-day technical seminar on the methods and procedures used to determine hazard classification and spillway hydrology for dams within Colorado. It's being facilitated by the Colorado Division

of Water Resources, Dam Safety Branch, and will be held in three different locations on March 15-16 in Grand Junction, April 5-6 in Loveland, and April 19-20 in Colorado Springs. Please plan to attend and take advantage of this excellent opportunity. Registration is required. For more information please the CASFM website.

We are also pleased to help promote the seminars and classes provided by the Urban Watersheds Research Institute (UWRI). Their 2011 schedule has been released and can be found at www.urbanwatersheds.org.

We are also evaluating interest in short but very practical ½-1 day workshops. An example was the recent 4-hour workshop on trends and challenges in floodplain management, No Adverse Impact, and public liability held on November 16 in Fort Collins. The workshop taught by Ed Thomas of Michael Baker Jr., Inc. was well attended by 50 people. Special thanks to Brian Varrella and Basil Hamdan for helping facilitate this workshop. Other potential upcoming ½-1 day workshop topics include stormwater quality hydrology, bioretention/rain gardens, a CFM refresher course, design and specifications for sculpted concrete drop structures, the National Levee Safety Program, and a computer based bridge hydraulics (HEC-RAS) training. Scholarship Committee

The Scholarship Committee is gearing up for the selection of the 2010-2011 scholarship award recipients. CASFM offers two scholarships each year: the CASFM-UWRI Scholarship is funded by the Urban Watersheds Research Institute and is awarded to an undergraduate student in the field of Civil Engineering; the CASFM-Ben Urbonas Scholarship was established in 2002 (renamed in 2008) and is awarded to a graduate student studying in a field closely related to the goals of CASFM.

The committee, which includes Danny Elsner, Liz Staten, Nancy Love, Jeff Cheng and Carrie Herbolsheimer, has been working on re-establishing contacts with the local ABET accredited universities in an effort to boost the number of scholarship applications we receive. Notices will be sent to the schools in January and applications will be due in March. For each scholarship, we will interview the top three applicants, hopefully announcing winners by May. Applications are available on the CASFM website, so encourage any students you know who qualify for the scholarship to apply! Outreach Committee

The outreach committee held its final meeting of 2010 on August 18th to discuss upcoming projects. The committee is actively seeking ideas for 2011 so please contact the committee chair if you have an idea or are interested in becoming actively involved in an upcoming project.

One thought is to better involve the local non-engineering community at next year's CASFM conference. It may be possible to coordinate with the local newspaper to run a short article, find some time to host a Q&A with community officials, or coordinate an inlet labeling program with a local school, or similar group. The outreach committee will also continue to spearhead CASMF's involvement with the Colorado Municipal League (CML). A session topic was submitted to the CML conference committee in mid-November. If selected, CASFM will host a plenary session at the CML conference in Vail held June 21 - 24 to discuss the following topics:

- Colorado's New State Floodplain Regulations
- National Trends in Floodplain Management
- The State Flood Risk Symposium
- Reducing loss of human life and property from flooding and storm drainage.
- Preserving the natural and cultural values of floodplains.
- Avoiding actions that can worsen flooding.
- Preserving the quality and health of our water courses.

CRS Committee

CRS Committee Active in State Floodplain Regulations Process

The CRS Committee spent the last few months of 2010 discussing the CWCB's proposed State Rules and Regulations. Many CRS Committee members attended the State Rulemaking Hearing and provided testimony on behalf of their respective communities. The Committee wishes to thank the CWCB staff members for providing these opportunities for discussion. Once adopted by communities, the new State Rules will provide uniform minimum credit for certain Higher Regulatory Standards (CRS Activity 430) for communities participating in the CRS.

CRS Committee Making Training Plans for 2011

Plans are being made for two CRS training opportunities in 2011. Colorado will host a week long field deployed CRS training class. This is the same course offered at EMI and will provide participants with in-depth information about each of the credit-

able CRS activities. French Wetmore is expected to be the primary instructor for this course. The CRS Committee is also going to sponsor a training class on CRS Activity 510-Hazard Mitigation Planning. This course will be valuable to consultants, floodplain administrators and emergency management personnel. Numerous communities in Colorado have FEMA approved Hazard Mitigation Plans, but are not receiving CRS credit. This class will be an opportunity to learn about the CRS requirements and how to apply for CRS credit. Sherry Harper with ISO and Marilyn Gally, Colorado State Hazard Mitigation Officer are expected to be the instructors for the Hazard Mitigation course. Additional information on dates and locations for these trainings will be sent out via an e-mail from CASFM.

Stormwater Quality Committee

The Annual Water Quality Field Trip

The Stormwater Quality Committee is starting to think about what sites to tour during the annual water quality field trip in June. The 2010 field trip was a success with a full bus and a number of diverse sites. We are looking for sites that provide similar benefit and opportunity to the sites toured in 2010. The High Plains Environmental Center represented a sustainable approach to stormwater management. The Highland Bridge Lofts rain garden provided a good example of integrating a multi-use stormwater BMP into a highly urbanized setting. Witnessing construction BMPs "in action" at the CDOT BMP Training Facility reinforced the importance of good BMP installation techniques. The green roof at the Denver Botanic Gardens, crediting proper design including thoughtful consideration of vegetation and irrigation practices, dispelled misconceptions about the use of this BMP in a semi-arid climate. New BMP Research Partially Funded by CASFM

At the general meeting in November, CASFM elected to contribute funding to a BMP test site. Basil Hamden of the City of Ft. Collins and Chris Carlson of Loveland have designed a rain garden site adjacent to a Ft. Collins city parking lot. Dr. Jan Cipra and Chris Olson from Colorado State University will assist with the media design and monitoring effort. The project will measure runoff reduction and evaluate a new bioretention medium that includes STA Class 1 compost with high leaf content. The team plans to present results at a future CASFM conference.

CWCB Update

In 2010, the Colorado Water Conservation Board undertook an effort to update its statewide Floodplain Rules and Regulations. After significant outreach, the process culminated in a rulemaking hearing that was held in Berthoud on November 15th. At that hearing, public testimony was heard, and the CWCB Board approved the proposed rules with slight modifications. These rules formally took effect on January 14, 2011. There are a number of provisions in these rules that all floodplain managers, whether in the government or private sector, should be aware of when doing business in Colorado.

A mandatory freeboard of one foot was enacted for all new and substantially improved structures. Flood proofing continues to be an option for nonresidential structures. Structures identified as critical facilities, as defined in the rules, must have two feet of freeboard, although no other new provisions are required for critical facilities. In addition, the rules require all new detailed studies to incorporate a 6 inch surcharge criteria for the purposes of defining floodways. This floodway requirement does not extend to smaller reaches that can revise official FEMA maps through a Letter of Map Revision (LOMR). The floodway requirement also does not extend to existing floodways that are not being

restudied. That is, the new rule does not trigger a need for a restudy, but when a restudy is performed beyond the LOMR scale, it should incorporate the new criteria for the new or restudied reaches. This requirement only applies to new studies initiated after January 14, 2011; any study already started prior to that day may still use the applicable local criteria in place at that time, regardless of eventual date of completion.

The rules allow for a three year transition period for local governments to update their ordinances. Projects that have a floodplain development permit or a valid FEMA CLOMR issued prior to the update of the local ordinance can be ATER CONSE exempted from the new provisions. A quidance document will be issued

common questions that have been asked regarding the rules and provides guidance on how to address transitional issues during the three year period. The CWCB will be preparing a model ordinance that reflects the new provisions, and this is expected to be available in early to mid 2011.
