
# **Deadly Tsunami a Somber Reminder**

### **CWCB Highlights**

The CWCB is pleased to announce that the draft final version of the "Colorado Floodplain and Stormwater Criteria Manual" will be published in late February. This document will serve as a technical guidance tool to assist local officials, engineers, and other interested parties with flood and stormwater studies and projects in Colorado. In conjunction with the upcoming release of the Criteria Manual, the CWCB has also embarked on mission to update and revise its Floodplain Rules and Regulations. A draft of the new rules will be presented to the Board at the March 2005 meeting in Glenwood Springs. A formal rulemaking process will begin shortly thereafter to obtain public comment and to complete the necessary steps in the rulemaking process.

Substantial efforts on the Statewide Water Supply Initiative (SWSI) have led to an executive summary and full report for this important study. SWSI information, including fact sheets, news releases, meeting dates and agendas, objectives, and other data, can be found at www.cwcb.state.co.us.

Lastly, the CWCB would like to congratulate Larry Lang on four decades of public service in floodplain management! Larry plans to retire from the CWCB during 2005 and will no doubt find plenty of meaningful ways to fill his time.

## **Colorado Map Modernization**

The CWCB received a substantial grant from FEMA under the newly created Map Modernization Management Support (MMMS) program to hire a floodplain mapping coordinator for Colorado. The CWCB advertised the annually renewable contract position through an RFP process and received 5 applications. A selection panel is actively evaluating the applicants at this time, and the CWCB hopes to announce an award in late January 2005.

The CWCB and UD&FCD have been actively involved with managing a number of countywide digital Flood Insurance Rate Map studies throughout the state. Significant progress has been made towards achieving state and regional mapping goals, and we expect a tremendous push over the next 5 or so years to complete a large number of mapping studies under the umbrella of Map Modernization. A CASFM Training Committee was formed at the November 18, 2004 CASFM General Meeting. The purpose of this new committee is to:

- Gather technical training needs from our members.
- •Provide technical training opportunities around the state.
- •Provide technical training opportunities at our yearly conference.
- •Provide quarterly technical training opportunities for our members.
- •Provide Continuing Educations credits for those whom attend technical training.
- •Coordinate joint technical training opportunities with members of APWA, ASCE, and IECA.
- •Oversee the distribution of CASFM funds for workshops and seminars.

During the first quarter of 2005 we will develop a technical training questionnaire, post the questionnaire on the CASFM website, compile technical training needs based on input received from our members, plan technical training opportunities for the remainder of 2005, and proceed to implement the 2005 technical training action plan.

### **2004 Grand Award Projects**

The title to this article is not a misprint, and it is true that the 2004 CASFM project of the year award was shared by two winners following a triple count of the votes that confirmed an amazing tie. The votes were collected following the project presentations at the annual conference in Glenwood Springs. This goes to show that your vote really does count!

One of the winning projects was entitled "Goose Creek Drainageway Improvements in a Developed Urban Environment". This project is located in Boulder and was completed by the City of Boulder, the UD&FCD, and ASCG Incorporated. This



project resulted in the removal of 98 structures from the 100-year floodplain, 75 structures from the conveyance zone, and 71 structures from the high hazard zone.



The other winning project was entitled "Comprehensive Stormwater Management for Stapleton Development" and involved project partners from the City and County of Denver, the Urban Drainage & Flood Control District, Forest City Stapleton, Inc., Matrix Design Group, Inc., and EDAW, Inc. The reconstruction of the old Stapleton airport site is a model example of a modern comprehensive stormwater management plan integrating both engineering and ecology.

Both winning projects (group photo upper right) will be submitted to ASFPM to be considered for the "James Lee Witt Local

Award for Excellence". Nominations for that award are due by March 1, 2005.

The two runner-up projects presented at the conference were: The "Douglas County Grading, Erosion and Sediment Control Manual" was developed by Douglas County and Muller Engineering Company (photo above), and the "Sheldon Lake Drainage Improvements" project by the City of Fort Collins and Stantec Consulting, Inc. (photo right). A big thanks goes out to all of the applicants who provided submittals for award consideration.
