

UDFCD Volume 3 Update

UDFCD is currently rewriting Volume 3 of the Urban Storm Drainage Criteria Manual (USDCM). The goals of the rewrite include updating design criteria and maintenance recommendations, promoting volume reduction, and improving readability of the manual.

Significant changes include the following:

- Increased emphasis related to runoff reduction, which is Step 1 of the Four Step Process. Although this important step has always been in the manual the new release will include quantifying stormwater management facility sizing credits using quantitative methods when MDCIA and LID measures are implemented.
- Substantial revision to design criteria for several BMPs already in the manual and inclusion of BMPs not previously in this manual. Green roofs and Underground BMPs will be added. Although UD-

FCD continues to strongly recommend treatment of runoff above ground, it also recognizes the need to provide guidance related to underground BMPs when surface treatment is not possible.

- Revision and expansion of the Construction BMPs chapter.
- Addition of supplemental guidance to promote more effective implementation of BMPs. This information is typically provided in the form of "call-out" boxes. While this manual remains focused on engineering design criteria, UDFCD also recognizes that it is helpful for designers to be aware of why certain criteria have been developed, how various practices can best be implemented on a site, opportunities to consider, and common problems to avoid.
- New Excel[™] workbooks to assist in BMP selection based on site specific conditions, BMP performance expectations and life cycle costs.

Scholarship Committee

This is the active time of year for the Scholarship Committee. We teamed up with the American Council of Engineering Consultants (ACEC) scholarship committee this year in an attempt to get the word out about the CASFM-UWRI Scholarship via a well-established network. The ACEC committee has worked hard to market all of the major colleges and universities in Colorado and we felt by utilizing their resources we would have a better chance of informing students about our scholarship as well as receiving a larger number of applications. After reviewing the 37 applications received, we have decided to award the scholarship to Charlotte Van Voast, a civil engineering student in her junior year at CU-Boulder.

We interviewed three applicants for the CASFM-Ben Urbonas Scholarship, which is awarded to a graduate-level student studying in a field related to the goals of CASFM. The committee decided to award the scholarship to Jason Messamer who is obtaining his Masters of Science in Civil and Environmental Engineering at Colorado State University. Jason will be taking advantage of the opportunity to briefly present the focus of his graduate study to the general membership at the conference lunch on Wednesday.

Outreach Committee

For the first half of 2010, the outreach committee will be focusing our energy on the Colorado Municipal League Conference, which will take place in Breckenridge from June 22nd through June 25th. The Colorado Municipal League is a nonprofit, nonpartisan organization that has served and represented Colorado's cities and towns since 1923. Currently, 265 of Colorado's 271 municipalities (representing more than 99 percent of the state's population) are members of CML and benefit from advocacy, information and training services. From CASFM's perspective, CML provides a unique opportunity to introduce our organization's position on floodplain management to a large group of individuals, including public works directors, City/Town engineers, stormwater program managers, planning directors and elected officials. As such, the outreach committee is preparing a CML membership/sponsorship application and will also host a presentation at the CML conference to showcase techniques for preserving the natural and beneficial values of floodplains adjacent to development projects. In addition, the presentation will cover Stormwater Management 101, Low Impact Development (LID) and National Pollutant Discharge Elimination System (NPDES) regulations.

The outreach committee is also hoping to "reach-out" to the non-metro regions in order to facilitate interaction between the regions. Our goal is to work with the regional committee chairs to foster a stronger sense of connection with the larger population of CASFM members, which largely reside along the Front Range.

CRS Committee

The CRS committee is off to a great start in 2010. We began the year with a lunch meeting on Feb.1st

One of the main discussion topics by the Committee at recent meetings has been about the State's Proposed Floodplain Regulations. Kevin Houck from the CWCB gave an overview of the proposed regulations and answered questions. Another initiative by the State is the "Colorado CRS Strategy." The State wants to further promote participation by communities in the CRS and is researching activities that may be available as Uniform Minimum Credit based on current of future State or Regional activities.

The CRS Committee is actively planning several trainings for the year. We hope to be able to offer training on CRS Activity 430 – Higher Regulatory Standards in partnership with CWCB's outreach on the State's Proposed Floodplain Regulations. It is expected that this training would take place in early April. CRS Activity 510 – Floodplain Management Planning and the connection with All Hazard Mitigation Plans is the planned topic for a training session in early Fall 2010. Stay tuned for more information about these future training opportunities.

Floodplain Committee

The Floodplain Committee accepted an important assignment during the CASFM Annual Conference in September on the issue of non-levee embankments. A rather large number of CASFM members expressed interest in working on this assignment, and thus became Floodplain Committee members! Several meetings were held late last year. The intent was to share some Colorado experience and perspective with ASFPM, with the hopes this would drive a national discussion and affect change through FEMA headquarters. I worked up a draft letter which was distributed for comment. The letter was delivered to ASFPM, FEMA HQ and FEMA Region VIII in early March. The letter was also distributed at the Operating Partners Focus Group, which includes FEMA HQ, and their program management consultants, USACE Flood Risk Management Group, ASFPM and NAFSMA. FEMA requested that AS-FPM recommend to FEMA HQ a way forward on the issue of non-levee embankments. We understand the Mapping and Standards Committee of ASFPM will accept this action item. My congratulations to the Floodplain Committee for a truly worthy effort on a matter of national interest. The Floodplain Committee will continue to monitor developments on this issue. -David Mallory

Colorado Flood Forecast

Wet and Cool Spring Expected Statewide

The Colorado Water Conservation Board (CWCB) in cooperation with other members of the Colorado Flood Task Force, continues to monitor spring flood potential created by snowpack conditions and long-range climate forecasts. 2010 has been a dry year thus far for a large portion of the state, and the potential for flooding is considered to be low as of mid-March.

While the southern half of the state has made a good recovery from dry early-winter conditions, there are no watersheds in the state currently being listed as "on watch" for snowmelt flood potential. This is only the second year since 2004 for which this is the case. As of March 18th, the snowpack levels for state watersheds ranges from a high of 109% of normal for the Rio Grande watershed to a low of 74% of normal in the Yampa and White River Watersheds. Generally, a value of 130% or greater puts the watershed on a watch list to be monitored throughout the spring, although lower numbers can do this as well on a case-by-case basis. It should be noted that as of March 18th, two areas of the state are considered to be in drought status – one small area in extreme Northwestern Colorado which also extends into Wyoming and Utah, and a slightly larger area encompassing portions of Grand, Routt, and Jackson counties. While these areas together only account for 4% of state land area, this number could grow if recent dry weather continues in the northern areas of the state.

The good news is that climate forecasts indicate the likelihood for colder than normal conditions along the east half of the state and wetter than normal conditions statewide. The wetter conditions are expected to be more prevalent east of the Continental Divide, especially in SE Colorado. These wet conditions are expected to last well into the spring and may even intensify as the summer months approach. At this point, it is not expected that these wet conditions will overcome a dry or average winter thus far, but it should do well to eliminate dry conditions if the wet weather materializes as forecast.
