1. Introduction and welcome

2. Secretary Report – Deb Ohlinger

A quorum was present. The minutes from the November 9, 2006 meeting were distributed. One correction was noted. The minutes were approved by a motion and a vote.

3. Treasurer Report – David Mallory

The Treasurer's Report was distributed. David noted that the report was essentially a yearend wrap-up. The 2007 proposed budget was presented, discussed, and approved by a motion and a vote.

4. Regional Representatives' Reports

No regional representatives were present.

5. Committee Reports

- a) Floodplain/CFM No report was made.
- b) Stormwater Quality No report was made.
- c) Scholarship The CASFM scholarship was officially awarded to Rob Rahrs of HDR Inc., who was present.
- d) Outreach Chuck Childs reported that he hopes to have a CASFM booth at the Colorado Municipal League (CML) conference in June. He would like volunteers at the conference to either man the booth or participate in roundtables. John Pflaum wondered if certain agencies had internal newsletters and suggested CASFM provide them with an article about CASFM to include in the newsletters. The ASCE water resources group meeting is on January 18th. Improved communication between the ASCE group and CASFM could be beneficial.

- h) Conference Robert Krehbiel reported that 40 of 200 attendees turned in 2006 conference evaluations. He would like to see more participation. Evaluation results were distributed and discussed.

6. 2007 Conference (CASFM/Arid Regions)

Considerable discussion about the conference plans took place. Following are the resulting key points:

The conference priority is the Arid Regions conference and then the CASFM conference. Therefore, the ASFPM logo should be more prominent in materials. John Pflaum noted that there will be a Colorado awards program that anyone can attend. Chad Kudym will coordinate a sponsorship program. Awards submittals will likely be moved to the end of May instead of the end of June. The notice for registration will likely take place at the end of May. The call for papers deadline will be at the end of March and the call for awards deadline will be the end of May.

Workshops that will help draw in people from other states were discussed. One workshop could be debris flow mitigation projects in Vail. The first day will be workshops, with the typical conference the remaining days. For the plenary session, it might be interesting to have a representative from each state discuss an event that has happened in the past and what has been learned from it (such as the Fort Collins flood).

The CFM review will be on Tuesday and the exam will be Wednesday morning. Internal meetings for conference organizers were recommended.

7. FEMA NFIP Conference

The conference will be held at the Adams Mark Hotel in Denver, April 29 through May 3, 2007. The conference targets the insurance industry and expanded to include mapping and flood insurance. There is an opportunity for CASFM to participate in the 2007 conference by proctoring the CFM exam, conducting field trips, organizing a 5K run, or hosting a vendor booth. People interested in helping with the conference should contact Kevin Houck. In Philadelphia, the conference was attended by approximately 800 people.

8. CASFM Magazine Update

The first publication for 2007 will be self-published. Kevin would like submissions before January 31st for the self-produced newsletter to be published in February. The second publication will be the Open Channel magazine.

9. Other Business

- c) Items not on the agenda Kevin Doyle noted that he is trying to organize a workshop to follow the UDFCD workshop on February 20th.
