Flood Mitigation Assistance Program

The FMA Program Is Authorized By Section 1366 Of The National Flood Insurance Act Of 1968 As Amended (NFIA), 42 U.S.C. 4104c.

- Annual Program
- Funded by the National Flood Insurance Program (NFIP)
- 2017 Funding \$160 million
- BCA & Environmental & Historic Preservation Requirements.
- Projects Must Somehow Reduce Flood Risk To Properties With NFIP Insurance Policies
- Subject to a 75% Federal and 25% Local cost share
- Projects capped at \$10 million federal share

Pre-Disaster Mitigation Assistance (PDM)

- Annual Program
- Highly Competitive, grant applications compete nationally
- 2017 Funding \$90 million
- Projects must demonstrably reduce risk by passing a Benefit Cost Analysis (BCA)
- Subject to an Environmental and Historic Preservation review
- Subject to 75% Federal and 25% Local cost share
- Projects capped at \$4 million Federal share

- Flood Risk Reduction
 - Localized and Non-Localized
- Property Acquisition & Demolition
- Property Elevation
- Dry Floodproofing
- Climate Resilient Mitigation Activities

Flood Risk Reduction Projects

Lessen Frequency/Severity of Flooding In An Isolated Area/Drainage

- Stormwater management Projects:
 - Culverts, Drainpipes, Pump Stations, Floodgates, Detention/Retention Ponds
- Flood Protection Measures for water and sanitary sewer systems
- Slope stabilization or grading to direct waters away from facilities
- Flood Protection and Stabilization measures for roads and bridges

Flood Risk Reduction Projects

- Non-Localized (eligible for PDM only): Lessen Frequency/Severity of Flooding In A Regional Drainage/Basin
 - Construction, demolition or rehabilitation of the following:
 - Dikes
 - Dams
 - Levees
 - Floodwalls
 - Large-scale Channelization

Climate Resilient Mitigation Activities

- Floodwater Diversion, Storage and Recovery
 - Diverting floodwaters from a stream, river, or other body of water into a wetland, floodplain, canal, pipe or other conduit and storing them above ground using green infrastructure methods
- Aquifer Storage and Recovery
- Emphasis:
 - Nature based design and green infrastructure
 - Restore or replicate a site's natural function

FMA – Advance Assistance

- Provides funding to assist communities with developing mitigation strategies and obtaining data to prioritize, select and develop viable community flood mitigation projects.
- Funding capped at \$100,000 Federal share

Ineligible Projects

- Projects That Don't Reduce Risk To People, Structures, Infrastructure
- Projects That Have Already Occurred/Started
- Non-Stand-alone Projects (Contingent On A Larger Project)
- Sole Purpose of Open Space Acquisition of Unimproved Land
- Incompatible Property Acquisitions
- Project Spurred By Lack of Maintenance
- Inadequate Future Maintenance Plan Following Project Completion

Ineligible Projects Continued

- Negligence or Intention Actions (Activities to Remedy Code Violations, Reimbursement of Legal Settlement, Court Order or State Law)
- Projects Without Increased Level of Protection
- On or Associated With Federally Owned Land or Facilities
